






## **Board Structure**










High-voltage battery system with 70 kWh capacity and up to 800V system voltage



Electric motor with 115 kW continuous power, 550 Nm nominal torque and up to 1200 Nm peak torque


Charging power of over 50 kW possible with generator at the carrier diesel engine
